Diagnostic insights & action learning: Practitioner innovation projects

Innovation projects, whether practitioner innovation projects or organisational innovation projects will enable active experimentation with new and innovative approaches to teaching and training, drawing on aspects of individuals CPD learning, to include international insights, enabling benchmarking and standardisation, to raise standards and drive quality improvement in further and higher technical teaching and training.


All learning and project outcomes, will be disseminated through the Centre of Excellence membership, and across education sectors throughout the UK, to ensure effective practice sharing, and the raising of standards, while helping to inform, shape and design the development of our WorldSkills UK training programmes.

Innovation Projects

The Network for Innovation invites you to apply to undertake small scale pratitioner innovation projects and larger scale organisational innovation projects to support the raising of standards, and making improvements to your technical teaching and training, aligned to priority themes, through continuous professional development (CPD) activities.

Funding of £5,000 is available to support successful applications.


The innovation projects are short-term pieces of development work which aim to improve teaching and learning by developing approaches, experimenting, and then reflecting on the outcomes, refining them, and sharing findings and learning. At the heart of the innovation project approach is the cycle of action-reflection-action, shown below.



Innovation project proposals can contribute to your curriculum/ occupational area self improvement plan, or the organisation's self improvement plan to support a whole organisation approach to improving the quality of technical education and training, to ensure positive learning experiences and outcomes for learners and apprentices.

For example, a project could aim to maximise learning in digital, advanced manufacturing, or practical science sessions making effective use of technology, through identifying and piloting successful strategies for improvement, or a project could develop and trial curriculum resources to address a particularly tough topic. These projects enable a small, focused piece of work linked to improving the quality of further and higher technical education and training.

Applicants apply individually and must have the support of a senior leader within their organisation. The organisation, to be eligible for Skills Innovation Funding, must be registered with the WorldSkills Centre of Excellence. If your organisation is not registered with the Centre of Excellence it is possible for a member of the senior leadership team to register using this <u>link</u>.



Key Success Factors

Successful projects are likely to:

- be focused around making improvements in further or higher technical education teaching and training, drawing on national and international best practice, particularly in the following identified key areas:
 - Digital
- Advanced Manufacturing
- Net Zero
- Health and Life Sciences

However, applications will be considered from all 15 technical routes.

- have clear objectives, milestones, and measurable outcomes
- have performance indicators to measure impact
- align and link into programme and organisational improvement CPD plans
- have support and commitment from senior managers, who have also registered their organisation with the WorldSkills Centre of Excellence
- have tangible outputs that can be used to share effective practice
- be collaborative in nature, so learning is shared, and impact is maximised throughout the UK, and through international partnership meetings and international exchange visits.

Project leads will be supported by expert WorldSkills UK mentors to develop action plans for activity, producing projects with clear and measurable outcomes. Project leads will be responsible for producing short interim and final reports, enabling activity to be disseminated widely across further and higher education sectors, throughout the UK, and through WorldSkills UK international partnership meetings, and international exchange visits.

The closing date for applications is 19 March 2024. Senior manager support for participation in the project must be included at the outset. Your organisation will need to be a member of the WorldSkills UK Centre of Excellence to be eligible for skills innovation funding. If your organisation is not a member, and would like to register, please use this <u>link</u>.

The first £2,500 payment will be made at the beginning of the project, prior to 31 March 2024, following the acceptance of a satisfactory action plan, and the final payment of £2,500 will be made on receipt of the final project report.

Successful applicants will be invited to attend a "Getting Started" briefing workshop in March. This will facilitate action planning and enable participants to discuss and identify impact measures for their projects, as well as clarifying outputs, timescales and plans for dissemination.
